# TERMS AND CONDITIONS OF THE CONTEST "BEST OPINION"

#### I. GENERAL PROVISIONS

- 1. The Competition organiser and the prizes' founder is Internet Union S.A. based in Wroclaw at ul. Złotnicka 28, registered in the register of entrepreneurs of the National Court Register kept by the District Court for Wrocław, Fabryczna VI Commercial Division of the National Court Register under KRS no 0000388937, NIP 8943024998, Regon 021547015 (hereinafter: Organiser).
- 2. The competition is organised in the territory of Poland. Participation in the Competition is voluntary and free of charge.
- 3. The Organiser declares that the Competition is not a game of chance, a raffle or a bet reciprocal, promotional lottery, the outcome of which depends on luck, or any other kind form of a game of chance provided for in the Act of 19 November 2009 on games (Journal of Laws of 2009, No. 201, item 1540, as amended).
- 4. The announcement of the Competition is placed on the Organiser's website at the internet address https://moi-co.pl/2021/11/05/konkurs-opinie/
- 5. Before participating in the Competition, the Competition Participant should familiarise himself with the Competition Rules. By entering the Contest, the Contest Participant declares that he has read the Regulations and accepts all its provisions and rules described.
- 6. The competition is organised in the period from 01/11/2021 to 31/12/2021 to time. 23:59.
- 7. Applications for the Competition are published on the territory of the Republic of Poland Polska in the period: from November 1, 2021, to December 31, 2021, until 23:59.
- 8. The competition is entitled "BEST OPINION". The competition task is meeting all of the following conditions:
- a) searching for the Organiser's brand "MOICO" in Google Maps,
- b) placing a comment on the services in the reviews of the Google MOICO browser provided by the Organiser (opinion).
- 9. The organiser expects to select the competition's winners every month for the duration of the Competition. Settlement of the Competition and announcement of the Winners by sending an e-mail to the persons chosen by December 5, 2021, and by January 5, 2022
- 10. The Competition is conducted solely based on these Regulations and generally applicable law, particularly the provisions of the Act of April 23, 1964, the year of the Civil Code.
- 11. The Organiser declares that Google Maps does not create, administer, support, or sponsor the Contest.

### II. CONTESTANT

- 1. The Participant of the Competition may be an adult person with a total legal capacity and residing in the territory of the Republic of Poland, meeting the conditions set out in the Regulations.
- 2. By applying and participating in the Competition, the Participant agrees to the processing your personal data for the purpose of proper participation in the competition, verification data of the competition participant in terms of eligibility to participate in the contest and exercise the rights and obligations indicated therein, and make their public data in case of winning the competition. The contestant can access your personal data and correct or request their removal.
- 3. A participant may only submit one answer. If a participant submits more than one answer, the answer sent will take part in the Contest first.
- 4. Contest entries may not violate the law or violate the rights of persons (entities) of third parties, in particular, may not contain infringing content, generally applicable provisions of law, content contrary to decency, in particular, considered offensive, associated with violence, racism or discrimination on any grounds, content relating to politics, religion (incl religious symbols), gambling, alcohol, and tobacco products that may offend religious feelings or about illegal activities, images of people naked or partially undressed, both adults and children (including photos of artistic works), images of well-known people, in particular actors, musicians, athletes and characters from animated films, addresses, telephone numbers, website and e-mail addresses, personal data, including numbers such as PESEL, NIP, REGON, photos of cash in any form.
- 5. The participant of the competition, by sending an answer to the competition task as part of the competition, transfers to the Organiser economic copyrights for any use of the content sent as part of competition applications, in particular by adding a logo of the Organiser, publication on the Internet, in the Organiser's social media channels, use in promotional activities of the Organiser, as well as for the purpose conducting and adjudicating the competition.

#### III. WINNER OF THE COMPETITION

- 1. The organiser will select the winners of the competition based on a subjective assessment of submitted applications/opinions. The Organiser will choose 5 (in words: five) winners in each month of the competition, who will receive the prize:
- a) for the 1st place, a voucher worth PLN 100 will be ordered via the portal PYSZNE.pl, voucher value: PLN 100, and Voucher expiry date until April 1, 2021.
- b) for taking places from II to V, a voucher worth PLN 50 per order via PYSZNE.pl portal, voucher value: PLN 50, Voucher expiry date until April 1, 2021
- 2. The winners will be informed about the awarded prize via e-mail sent by the competition's Organiser with information about the winners.
- 3. The prize cannot be exchanged for another. The prize cannot be exchanged for monetary value.
- 4. To transfer the prize, each winner should, after receiving information about winning the competition, submit it within 7 days from the date of notification of the winning message to the Organiser via e-mail and fill out the prize collection form. The laureate should indicate the data required to issue the prize in the form. Failure to send back a correctly and completely completed form on time indicated by the Organiser (at least 14 days) makes it impossible to issue the prize, meaning the winner will forfeit it.
- 5. An additional cash prize is assigned to each main prize in the amount of 10% of the value of the award. An additional cash prize is provided for income tax on winnings. #### IV. PERSONAL DATA

- 1. The Organiser will use personal data provided by the Participant solely for the proper conduct of the Competition and the awarding of prizes. The data provider may at any time request their removal and correction.
- 2. The competition participant agrees to the processing and sharing of personal data: surname and first name, e-mail address, and username in the Google Maps portal.
- 3. The administrator of personal data collected in connection with the Competition is The organiser, i.e. Internet Union S.A. with its registered office in Wrocław at ul. Złotnicka 28, registered in the Register of Entrepreneurs of the National Court Register conducted by the District Court for Wrocław Fabryczna, VI Division Commercial Register of the National Court Register under KRS number 0000388937, NIP 8943024998, REGON 021547015.
- 4. Personal data of Participants are processed by the Organiser solely for the purpose of and to the extent necessary to conduct the Competition, i.e. for identification purposes of the Participant, issuing the Prize and publicly announcing the names and surnames of the winners and publishing the winning entries.
- 5. Period of processing the personal data of participants who did not win a prize will end two months after the end of the Competition. Period processing personal data of participants who won awards in the Competition will end five years from the end of the calendar year in which the period of the Competition has finished.
- 6. The legal basis for processing personal data is the consent of the Competition participant.
- 7. The participant has the right to withdraw consent at any time without impact on the lawfulness of processing based on consent before withdrawing it.
- 8. The Organiser will store Personal Data in a manner consistent with the applicable regulations, including, in particular, protecting them against disclosure to persons unauthorised, removal by an unauthorised person, processing with infringement and alteration, loss, damage or destruction.
- 9. The Organiser may ask the Participant to consent to processing other personal data of the Participant or for other purposes expressly indicated by the Organiser.

- 10. The Participant has the right to access and correct their Personal Data. Any correspondence regarding the processing of Personal Data should be addressed to the Organiser.
- 11. The participant has the right to request the administrator to access their personal data, their rectification, deletion or limitation of processing and the right to object to processing, as well as the right to transfer data. The participant can complain to the supervisory body the President's Office for Personal Data Protection.
- 12. Providing Personal Data is voluntary. However, failure to provide Personal Data necessary to contact or verify the Participant or determine the right to the Prize may lead to exclusion from the Competition or refusal to grant the right to Awards.
- 13. Participants' personal data will not be transferred to a third country (i.e. other than a Member State of the European Union) or an international organisation.
- 14. Personal data will not be used to make decisions based solely on automated processing, including profiling.

#### V. COMPLAINTS PROCEDURE

- 1. The complaint procedure does not apply to the Organiser's verdict, which is an expression of subjective evaluation of applications by the Organiser.
- 2. A person with substantiated objections to the course of the Competition due to non-compliance of the course of the Competition with applicable law, including these Regulations, may submit these reservations by e-mail (sending e-mail) within 3 (in words: three) days from the date of finding by this person irregularities, but not later than within two weeks from the publishing date the results of the Contest to the following address: enjoy@moico.pl
- 3. The Organiser will consider the complaint within 10 (in words: ten) days from the date of receipt by the Organiser. About the outcome of the complaint procedure, the person reporting irregularities will be notified by post via e-mail sent to the address indicated in the application complaints.

### VI. FINAL PROVISIONS

- 1. The Organiser is entitled to change the provisions of these Regulations at any time without giving a reason, as long as it does not worsen the conditions of the participants' contest.
- 2. The Organiser may at any time invalidate the Contest and only settle it by giving reasons.

#### STATEMENTS:

- I declare that I know and accept the provisions of the Competition Regulations
- I consent to process the participant's personal data by the Organiser competition only for the purposes of the competition and to implement the rights and obligations arising from the contest.
